VIII. Salary and COLA: Newman/Lum

Lum discusses inquires received regarding salary interests. Discussions held regarding the salary structure are shared. Lum reviews list of interests with board members. Lum requests board members provide information regarding member interests which are necessary for decision making. Options for this year's COLA are discussed with a reminder that .75% has been used to offset the rise in healthcare costs. Lum proposes creating a decision-making framework for the board to address salary and budget decisions over the summer. Because the May revise comes out after the end of the semester, the framework will be helpful in providing an outline for decisions and will provide greater transparency for the board and members. Decisions regarding the retro and one-time money will need to be made. Discussion regarding the possibility of meeting over the summer is held. Lum reminds board of upcoming Salary Study sessions. The two sessions will be held on May 2 and May 9 from 3:00 PM to 5:00 PM. Smith discusses the interest of part-time faculty salary. Smith has requested the final accounting of 2020 – 2021 which is needed to go forward for the discussion of COLA.

IX. Executive Board Policies:

Newman requests team leaders from Executive Board retreat provide suggested revisions of board policies.

X. Part-time Compensation: (2nd Reading)

Beckum reviews proposed tiered compensation for board members. Three options are discussed. Lum clarifies part-time reps will have the option to opt into the three options. Lum moves to accept part-time compensation proposal, Sneed seconds the motion. Discussion held. Aldredge discusses the importance of logistics regarding funds that are allocated by commitment. Aldredge voices support for the motion. Lum calls for the question, Dimond seconds. Motion passes. Motion to accept compensation proposal passes by consensus.

XI. Honduran Labor Leader: (1st Read)

Torres discusses the Honduran School Vaccine Campaign. LRCFT and the Sacramento Central Labor Council have a long history of assisting the people of Honduras by building a hospital there ten years ago. A group of Honduran labor leaders is flying into Sacramento to meet with labor leaders and union members. A reception will be held on Sunday, May 15, at 6 pm. We have been asked by the CLC to provide any contributions to defray flight costs.

XII. <u>LRCFT Committee Appointments</u>: (2nd Reading)

Newman reviews appointments to the Reassign Time Review Committee. The members are Tak Auyueng, Leon Smith, Dana DeMercurio and Jesus Limon. Zhang and Newman will attend meetings. Limmaneerprasert moves to approve committee appointments, Telles seconds the motion. Motion passes by consensus.

Lum moves to suspend the rules, Limmaneeprasert seconds the motion. Motion passes by consensus. Newman discusses upcoming Salute to Labor Dinner. Dean Murakami will be honored at the dinner. Lum moves LRCFT purchase two tables at the Salute to Labor Dinner, Limmaneeprasert seconds the motion. Motion passes by consensus.
