V. Academic Senate Report: May 17 Shubb written report

- DAS voted to support a tenure-track PREP Counselor/Coordinator critical hire, to be employed at FLC. Intention is for the position to be "taken off the top" of the district's Fall 2023 allocations.
- DAS initiated a Work Experience/Internship Developers work group to begin immediately. The purpose of this group will be attempt to ensure faculty are consulted in the District's Sector Internship Developer project:

Sector Internship Developer Project Launch

Starting in 2021, the Career Education Council (CEC) approved Strong Workforce Program funding for the Sector Internship Developer (SID) project. Internships provide students an opportunity to gain experience in their field of study, expands their professional connections and gives them an advantage in the hiring process upon completion of their program. The goals of the project are to:

- 1. Increase the number of Career Education students who participate in paid internships (both general and for-credit), particularly for Disproportionately Impacted populations (Native American, African American, Latinx, AAPI).
- 2. Increase the number of vetted CTE work experience opportunities posted in Handshake.

Note that prior to the formation of this work group, neither Work Experience faculty, nor Academic Senate had been made aware of the existence of this program. 4 adjunct faculty were hired in Fall 2022 and appear to be working with a District supervisor, without ARC, FLC, & SCC Academic Senates knowledge. We are currently working on making sure each of these faculty are assigned a PRT.

• DAS passed a resolution from our Ethnic Studies Council that:

- Resolved that the Los Rios District Ethnic Studies Faculty Council urges our local college Academic Senates to recommend Ethnic Studies tenure-track professor positions receive the highest support possible during the Fall 2023 faculty hiring prioritization process. and
- Resolved, and the Los Rios District Academic Senate urge our local college Academic Senates to give all due consideration to the whereas statements in this resolution during the Fall 2023 faculty hiring prioritization process.
- DAS voted to support proposed revisions to R-3412 (Governance Academic Senate) to update processes for District Curriculum Coordinating Committee (DCCC), and strengthen collegial consultation with District Education Technology (DETC), which is currently a Non-Senate led committee.
- DAS discussed long standing concerns about collegial consultation, the individual email response from BOT
 President Knight to DAS President Shubb, inclusion of specific criteria in our semesterly Collegial Consultation
 Report, and plans for a BOT presentation about collegial consultation in June.

VI. Chief Negotiator Report:

Lum thanks all board members that attended the forums. The recorded forums were posted to the LRCFT YouTube Channel.

Lum has started work addressing Home Base at ARC and scheduling meetings for next couple of weeks. Lum discusses issues with embedded success coaches, received requested information on embedded success coaches at ARC.

VII. PAFC Report:

Kawamoto reports the PAFC did not have a quorum at the last meeting. Races for Fall 2023 are reviewed. The PAFC will focus on the mayor's race next spring. Kawamoto announces upcoming Wellstone event. PAFC's interests in politics and moving further to left of middle. Aldredge discusses concerns regarding political leanings of the PAFC. It is important to include all political parties.

IX. Part time Issues Committee: (Second Read)

Sneed announces appointment of Sarma Karsiere to the Part Time Issues committee. Karsiere will represent CRC. Telles moves to accept appointment, Aldredge seconds the motion. Motion carries.

X. LRCFT Release Time Recommendations: (First Read/Suspend/Action)

Newman reviews recommendations for board members. Aldredge requests point of clarification. Is the board voting on two separate issues, the President's reassign time and other listed positions? Jones speaks in opposition to the additional reassign time for the LRCFT President and voices concern for the additional release time that has been proposed for the Chief Negotiator as well. Lum clarifies the amount of release time the CN receives. During negotiations, the CN receives .6 and during non-negotiation semesters it is .4. Sneed voices opposition to any changes for Fall 2023. Faculty have submitted for their schedules for the fall. Sneed is opposed to merging the Graphic Design and Communications positions. Lum suggests proposes approving release time for the fall and reviewing each position to determine if the position is needed and/or receiving the appropriate amount of release time for the work. Lum suggests all release time positions be available to all faculty. Jenkins agrees that all release time should be available to all faculty, not just board members. Reese discusses the need to address the organizational structure of LRCFT positions. Rowe reminds board members that the current appointed positions were created and appointed by the past LRCFT President and was approved by the executive board. Aldredge

speaks in favor of allocating 1.0 to the LRCFT President. Fernandez addresses the President and CN positions. Both positions are the busiest positions of LRCFT. Neither position should receive less release time that is currently allocated. Jones gives historical perspective regarding the LRCFT President's position and does not recall a proposal to increase LRCFT President's release time from .6 to the current.8 the President is receiving. Jones discusses issues with no proposed release time for the college presidents who have requested additional assistance on their campuses. Newman gives background to current release time for the LRCFT President and findings that the position requires more work than the .8 currently given. Lum suggests going with the status quo with a commitment to address proposed changes for Spring 2024. Aldredge moves to vote on the LRCFT President's release time for Fall 2023, Dimond seconds the motion. Motion carries with 17 in favor and 2 opposed.

Beckum requests clarification for new release time positions. Newman clarifies the positions will be open to all. An application will need to be submitted for positions. Jenkins suggests all appointed position have term limits. Torres supports the suggestion for term limits.

XII. <u>Equity Minded Professional Development:</u> (First Read/Suspend/Action)

Lum reviews and discusses the proposed LRCCFT and LRCCD agreement on Equity Minded Professional Development. Lum thanks Shubb for her assistance and participation regarding the proposed MOU. Lum reviews changes to the original proposed MOU and discusses concerns and suggestions made by board members. Carbary moves to suspend the rules, Goodchild seconds the motion. Motion carries. Discussion regarding the proposed MOU is held. Goodchild moves to approve motion to approve EMPD MOU, Carbary seconds the motion. Motion fails with 8 in favor and 10 opposed. Roll call:

XIII. Authorize Steering to Negotiate Retro over the Summer: (Second Read)

Lum discusses proposal to authorize the steering team to negotiate the retro over the summer during off contract month. The steering team will schedule an executive board meeting over the summer, most likely in early August, to discern board interests in negotiating the Retro. Lum discusses the current proposed COLA and recommends 8% apply to the salary schedules. If the COLA comes in lower than expected, Lum suggests lowering the amount to the salary schedule to 5%. Discussion held. Smith requests the CB report for last year and this year. Carbary moves to authorize Steering to apply the COLA to the salary schedule at the highest possible percentage increase and to apply the highest possible retro by percentage. Limmaneeprasert seconds the motion. Motion carries. Discussion regarding a possible special executive board meeting to be held in the summer. The meeting will be held to discuss and approve of the proposed COLA distribution. Rowe moves to hold a special summer executive board meeting, Telles seconds the motion. Discussion is held. Motion carries with two opposed.

IX. Full-time Faculty Dollars: (Second Read)

Jones discusses proposal to have decisions made about full-time faculty dollars to come to the Executive Board before LRCCD makes decisions about full-time faculty hires. Aldredge moves to approve motion for full-time faculty dollars discussions, Jones seconds the motion. Perrone discusses issues with the proposal because of

LRCFT's inability to authorize to the district to hire faculty. Newman suggests changing the proposal language to indicate that steering should ask the district *each* semester what their plans and decision-making surrounding are regarding FT hires. Steering will bring that information back to the board. Aldredge accepts changes to the proposed motion. Motion carries with proposed changes.

X. <u>LRCFT Accessibility Taskforce</u>: (Second Read)

Cabary proposes Lauren Wagner from CRC be appointed to represent CRC on the task force. Aldredge moves to appoint Wagner, Limmaneeprasert seconds the motion. Motion carries.
