- I. Boylan convenes the LRCFT Executive Board 3:00 PM
- II. Public Comment: Chris Yatooma and Adeeb Alzanoon from the Sacramento Regional Coalition for Palestine Rights discusses the human rights of Palestinians living in occupied Palestine and Israel. A divestment resolution is presented and discussed. The passing of George Esquibel is announced, Boylan requests a moment of silence in his honor.
- III. Approval of minutes for February 21, 2018 approved by consensus. Agenda is approved by consensus with changes.
- IV. **Liaison Reports:**
  1. LCLAA – Kawamoto announces SEIU 1021 will be participating in the Cesar Chavez march.
  2. FACCC – Limmaneeprasert reports on the A&P conference. LRCFT was well represented, many students from ARC attended and lobbied.
  3. CFT – Sneed reports CFT will join an anti-gun violence rally on Saturday, March 24<sup>th</sup> during the CFT convention. Kawamoto discusses the lack of support for the College for All measure.

- VI. **Resolution on Divestment: (1<sup>st</sup> Reading)**  
Peshkoff presents and discusses proposed resolution. Discussion regarding the urging support from student senates is held.
- VII. **National Conference on Race and Ethnicity: (2<sup>nd</sup> Reading)**  
Motion to provide cost of registration and travel funds up to \$4500 passes by consensus.
- VIII. **Support of the COEA for Students of African Descent: (1<sup>st</sup> Reading)**  
Aldredge discusses the Celebration of Excellence and Achievement ceremony. LRCFT has supported the program with a contribution of \$2500 for the past several years. The contribution covers program costs. Discussion held.
- IX. **May 11<sup>th</sup> Undocu Leadership Conference & May 12<sup>th</sup> Beyond the Dream Conference: (1<sup>st</sup> Reading/Suspend)**  
Lum discusses the two conferences to be held in May. The Undocu Leadership conference is designed for students in Northern California to develop leadership skills. The Beyond the Dream conference focuses college outreach for high school Dreamers and their families. Telles moves to suspend the rules, Newman seconds the motion. Motion passes by consensus. Torres moves LRCFT support and endorse the conferences, Limmaneeprasert seconds the motion. Motion passes by consensus.
- X. **Honorium and Travel Funding: (1<sup>st</sup> Reading/Suspend)**  
Lum discusses funding of \$1000 to help share the cost of the keynote speaker for the Undocu Leadership conference and the Beyond the Dream conferences with Alianza. Lum moves to suspend the rules, Torres seconds the motion. Motion passes by consensus. Lum moves LRCFT contribute \$1000 for both conferences, Limmaneeprasert seconds the motion. Motion passes by consensus.

**XI. LRCFT Budget:**
