- I. Newman convenes the LRCFT Executive Board 3:00 PM
- **II.** Traugott moves to approve minutes of March 6, 2024, and changes to agenda. Torres seconds the motion. Motion carries.
- III. Public Comment: Mark Medina representative from DSA speaks to board members about their upcoming events. The next event's topic will be "Striking for the Public Good" on April 4 at Sierra 2 Center. The event begins at 7:00 PM. DSA would like to do tabling as SCC and speak to students in their classroom if faculty can allow time.

### IV. Survey of all faculty: Part-time Faculty Issues: (2<sup>nd</sup> Read/Action)

Smith discusses proposal to survey of all faculty regarding part-time faculty issues. Smith shares report from CFT on VCCFA's one-tier employment system shared at CFT's March Summit event. A LRCFT task force will need to be put together to look at legislation and to create the survey. Carbary asks if LRCCD would agree to a one tier system. Smith clarifies the proposal is for a survey of faculty and information gathering. Register supports surveying faculty but shares concerns about consequences to part-time faculty if implemented. Lum informs board members that there are several pieces coming into play that LRCFT would be able to use if a time came to implement this system. Motion carries.

### V. LRCFT Resolution Supporting DAS:

Jones informs board members a zoom meeting will be held on Friday, March 22 at 2:00 PM to discuss a resolution in support of DAS. Jones gives board members background. Friday's meeting will be to brainstorm for the creation of the resolution in solidarity of DAS colleagues.

### VI. Constitution and By-laws Post Retreat:

Henderson reviews proposed changes to Article 1 through Article 3. Discussion regarding proposed changes is held. More discussion regarding proposal changes needs to be held. Reese suggests tabling review of Article 3.3 and allot an entire board meeting to review, discuss and approve of proposed changes.

### VII. CFT's Accessibility Complaint:

Carbary discusses information received at the CFT conference in Sacramento this past weekend, LRCFT Execuvitve Board members who attended the CCC division meeting heard a summary from David Conway, LRCFT

and CFT's attorney, on the on-going CFT/CTA DEIA complaint. The complaint specifically pushes back on accessibility as a new component of faculty performance review, which is a new Title V Ed. Code requirement imposed by the Chancellor's Office without negotiation with unions at the local level. According to Conway, there is a strong legal case other groups who have filed lawsuits based on free speech which will kill the implementation of these regulations. Conway does not see the need to waste CFT's money on a lawsuit if the issue will be resolved with the lawsuits that are pending. Conway discussed self-reflection and, in his opinion, it is clearly not compliant. Conway also discussed the issue regarding unions negotiating an agreement that waives the constitutional right of members which means the district cannot force faculty make all documents accessible. Carbary reviews four options for negotiations Conway shared with attendees. Carbary shares information from the grievance workshop at the conference. Valuable information regarding grievances and timelines was discussed. Filing grievances and taking timelines into consideration is important. The next accessibility meeting will be held on Monday. Carbary will update the accessibility committee on new information. Aldredge suggests bringing the CFT training on grievances to LRCFT. Perrone and Henderson will be doing a grievance workshop in April. LRCFT should consider inviting the CFT representative that presented at the conference. Fernandez suggests LRCFT consider messaging around accessibility. There are faculty that feel LRCFT is anti-student. Torres reminds board members that it is important to bring issues to the board when we are in session not in the summer.

### VIII. Cuba Trip:

Newman announces faculty members have submitted interest in the Cuba trip. One part-time faculty member committed to going. The stipend for part-time board members was open to all part-time reps. Only one rep is able to go, LaQuisha Beckum. One full-time faculty member has committed to going, Newman is still waiting on the second full-time faculty member to respond

### IX. Stewards Committee:

Beckum reports on the Stewards committee. The committee has met twice in the past two weeks. The committee has suggestions for aligning stewards' duties and representative duties. Beckum reviews suggestions for board members. The committee is looking into college service for stewards. The committee invited Sara Smith to the last meeting to discuss level of work and grievance handling. Concerns regarding the ratio of stewards and part-time to full-time stewards as well as the required level of work was addressed. Considering LRCFT elections, the committee will be looking into timeline for Stewards elections. Jones suggests the committee look at the senate's structure who have already worked these issues out.

  - Over 500 student, faculty, labor leaders, and community activists marched on the Capitol. Students from community colleges across the state, Sac State, and UC Davis attended.
